

## **DIRECTIONS – (Updated 4/9/09)**

### **VIRGINIA SUPREME COURT 100 NORTH 9TH STREET**

Take 64 East to 195/Downtown Expressway. Get off at the 7th & 9th Street Exit. Take left onto 7th Street. Go up four blocks and take a right. Across from St. Paul's Church and State Capitol Building.

### **VIRGINIA COURT OF APPEALS 109 NORTH 8TH STREET**

Take 64 East to 195/Downtown Expressway. Get off at 2nd Street Exit. Go up to 2nd Street and take a left. Follow 2nd Street to Franklin Street and take a right onto Franklin Street. Go up to 8th Street and take a left. Across from State Capitol Building between Franklin and Grace Streets on the left.

### **CHESTERFIELD CIRCUIT AND GENERAL DISTRICT COURTS BUILDING 9500 COURTHOUSE ROAD**

Take 64 East to Powhite Parkway. After the \$.50 tollbooth bear to the left heading towards Chippenham Parkway/150 South. Follow Chippenham approximately 5-7 miles until you come to the Ironbridge/Chesterfield Exit (Route 10). Get off at this Exit. Follow Route 10 approximately 7-10 miles. You will pass the Chesterfield Airport on the right and the new Courthouse Building is on the left. Take a left on Courthouse Road.

### **CHESTERFIELD JUVENILE AND DOMESTIC RELATIONS DISTRICT COURT 9600 KRAUSE ROAD**

Same as above. Take a right onto Krause Road.

### **HENRICO CIRCUIT, GENERAL DISTRICT, AND JUVENILE AND DOMESTIC RELATIONS DISTRICT COURTS GOVERNMENT CENTER**

Take 64 West to the first Parham Road Exit. Keep straight on Parham approximately 3-5 miles until you see the Government Center on the right. Cross over Hungary Springs Road and take your next right. Follow signs to specific courts buildings.

### **RICHMOND CIRCUIT COURT RICHMOND GENERAL DISTRICT COURT - CIVIL DIVISION JOHN MARSHALL COURTS BUILDING 800 EAST MARSHALL STREET**

Take 64 East to 195/Downtown Expressway. After the \$.50 tollbooth, take the 7th & 9th Street Exit. Make left on 9th Street. After you cross Broad Street, the next street is Marshall, which runs one way going east. The John Marshall Courts Building is on the left. (Note: If you continue one block on 9th Street, through the light at Marshall, and take a left, there is a public metered parking lot on your right).

### **RICHMOND GENERAL DISTRICT COURT - CRIMINAL DIVISION 501 NORTH 9TH STREET**

Take 64 East to 195/Downtown Expressway. After the \$.50 tollbooth, take the 7th & 9th Street Exit. Go to 9th Street and take a left. Cross Cary, Main, Broad, and Marshall Streets. The courthouse will be on your right after you cross Marshall Street.

## **DIRECTIONS**

### **RICHMOND GENERAL DISTRICT COURT – CRIMINAL DIVISION MANCHESTER COURTHOUSE 10TH & HULL STREETS**

Take 95 South to Maury Street Exit. Follow this around to the stop light and take a left. Go to the second stop light (Commerce Road) and take a right. Go through two lights and at the third one, take a left.

### **RICHMOND JUVENILE AND DOMESTIC RELATIONS DISTRICT COURT 1600 NORTH 17TH STREET**

Take 64 East to 95 South back to 64 East to the Mechanicsville West/Route 360 Exit. Take your second right onto Fairfield Way. Look directly in front of you and you will see the Oliver Hill Court Building. It is across from the City Jail. You may also wish to follow the directions given for the Richmond City Jail.

### **RICHMOND CITY JAIL 1701 FAIRFIELD WAY RICHMOND, VA 23223 (804) 780-8615**

Take 64 East to 95 South. (Note that you will continue on same road. 64 East bears off to the right, heading to the Airport and Virginia Beach). Take Exit 74B to Franklin Street. Take a left at the light. Take first right at 15<sup>th</sup> Street. Take a left on to Main Street. Take a left on to 18<sup>th</sup> Street. Continue on 18<sup>th</sup> Street. You go through 3 or 4 lights and will pass Awful Arthur's, McDonalds, and the Venable Seed Company. Go around the curve and the jail will be on your right. Continue on to the intersection of 18<sup>th</sup> and Fairfield Streets. There will be a stoplight. Take a right onto Fairfield. The Richmond Juvenile and Domestic Relations District Court will be on the left. You may also wish to follow the directions given for the Richmond J & DR Court.
