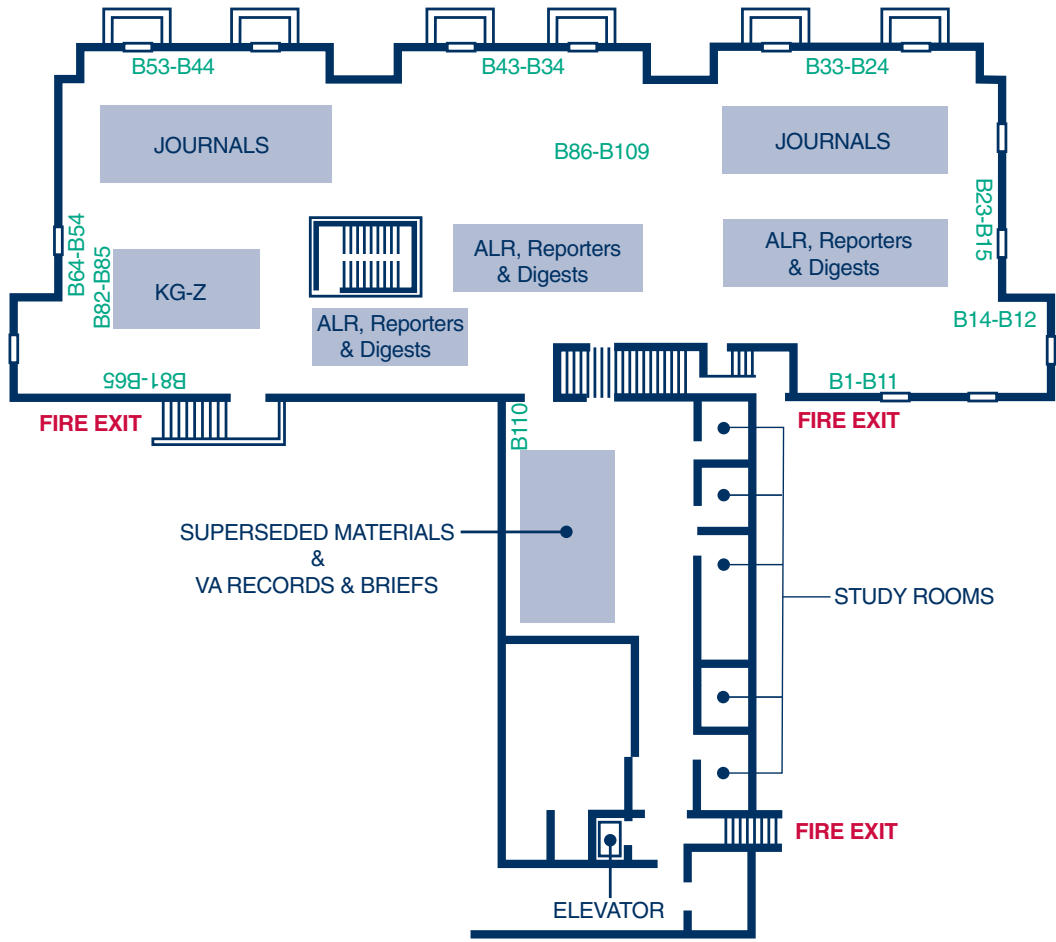
THIRD FLOOR
