**Exam Software.** All exams are administered using Exam4. Exam4 provides the student with their exam questions, a place to type their essay responses, and a multiple choice answer sheet (if applicable). All students are required to download and test the most up-to-date version of the Exam4 software as directed by IT services.

**Exam Timing.** Scheduled Exams must be taken on the day indicated above and started at the indicated time, either 10:30am ET or 10:45am ET. Flexible Exams may be taken any weekday of the exam period. Students taking a flexible exam may start any time after 7:30am ET, and must complete and upload their exam answer by 7:00pm ET each day. Thus, for example, students planning to take a 4-hour flex exam should plan to start their exam by 3:00pm ET at the latest; students may also begin a 4-hour flex exam at 4:00pm ET, but they will only have 3 hours to complete and upload their exam answer in order to meet the 7:00pm ET deadline.

**Where To Take Exams.** Students may take their exams remotely, or students may choose to take their exams in the law library by reserving a seat through the law library seat reservation system. IT services and administrative support are available to all students during the exam period regardless of where they take their exams. Students may not take exams in journal/advocacy offices, classrooms, or study rooms.
