

Research Guide : Researching Treaties and Agreements

### Introduction

Agreements among nations pass under a variety of different terms, including treatises, international conventions, international agreements, covenants, final acts, charters, protocols, pacts, accords and constitutions for international organizations. The differing names have no real legal significance and all similar documents may be referred to permanently as treaties. Treaties may be bilateral, meaning between two parties, or multilateral, meaning among several parties. Treaties are only binding upon the signatories to the agreement. This guide presents a selection of the resources available in the library to assist a researcher in finding treaties.

#### Treaties

Treaties to which the United States is a party are equivalent to federal legislation. Under U.S. law, a treaty is an agreement made by and with the advice and consent of the Senate, pursuant to Article II, section 2, clause 2 of the Constitution. Negotiation of treaties is the responsibility of the Executive Branch. The U.S. Department of State Foreign Service division generally conducts treaty negotiations. Once terms are agreed to, the President submits the treaty to the Senate for consideration. The Senate Foreign Relations Committee considers the treaty and reports to the full Senate. The Senate must approve the treaty by a two thirds majority. After approval, the President proclaims that the treaty has entered into force. There are other international agreements entered into by the United States that do not constitute treaties and do not require the advice and consent of the Senate to be binding. Such agreements are generally referred to as executive agreements.

-may provide the text of a treaty or reservation to a treaty and is often a god source for the legislative history of a treaty

-long delay in the publication of this resource, as much as 12 years

-contains text of treaties from 1776 to 1937

-volume 4 has a cumulative index and chronological list of treaties

Treaties and Other International Agreements of the United States, 1776-1949 (Bevans) [KZ236.1968.U5]

- -text of treaties and agreements in chronological order by date of signature
- -divided into bilateral treaties and multilateral treaties

Statutes at Large [Ref. KF50.U5]

- ---from 1776-1950, treaties and international agreement were published in the *Statutes at Large*
- -volume 8 contains all treaties between the U.S. and other countries from 1778-1845
- -volume 64, part 3 contains a cumulative list of all treaties and agreements included in volumes 1-64

Hein's United States Treaties and Other International Agreements Current Service [KZ235.3.U55a]

- —use United States Treaty Index and the Current Treaty Index to locate the correct microfiche
- -excellent source for recent treaties

### Status, Updating and Ratification

Once the researcher has located the text of the agreement, the status of the document must be determined. This includes determining the parties of a multilateral agreement, entry into force date, amendments to the original agreement. Un-ratified treaties do not die at the end of a Congressional session, thus it is important to determine where a treaty is in the ratification process. The following can all be used to accomplish the task:
